As you are aware we were appointed as statutory auditors of Arvee Laboratories (India) Limited by the Board of Directors in their meeting held on 17th July, 2021 which was subsequently approved by the Shareholders in general meeting held on 24th September, 2021.

We have completed our statutory audit for the year ended on 31st March, 2022.

We refer to our various communication and discussion with the management, wherein we have indicated that our fees level are not commensurate with the cost / efforts. Accordingly there is a need that our fee levels are increased to align with the audit efforts, which have significantly increased on account of reasons including enhanced reporting requirements. We have accordingly proposed to the management increased fees for the year 2022 – 2023 and 2023 – 2024. However the management has indicated that it is not in a position to accept the increased fees in view of COVID which has impacted the business of the company.

We have discussed this matter with the management and the Audit Committee.

Considering the reasons, as explained above, we would not be in a position to continue as statutory auditors of the Company. Accordingly please accept our resignation with effect from 17th June, 2022.

We thank the management, Board of Directors, Audit Committee and the staff for the co-operation extended to us during the tenure of our association as the statutory auditors of the company and wish the Company success in all its endeavours.
